## **DECISION:** Afghan Locally Employed Staff (ALES) Relocation Scheme

The approval of:

- 1. The Council to work in partnership with the regional Strategic Migration Partnership (South West Councils) and Devon County Council to support the Governments ALES Relocation Scheme under the Ministry of Housing, Communities & Local Government Afghan Relocation and Assistance Policy (ARAP)
- 2. That the Council commit to working with up to 3 families locally relocated under the ALES scheme within the support provisions provided by the Afghan LES Housing Costs Scheme

#### **REASON FOR DECISION:**

Following NATO's decision to withdraw military forces from Afghanistan, the Government have been working to relocate Afghan citizens including their families in the UK via the Afghan Relocation and Assistance Policy (ARAP.) These are Afghan Locally Employed Staff (LES) who have worked for the UK to support our forces.

The ALES Housing Costs Fund nationally is put in place to support Local Authorities with offers of housing accommodation support, either directly provided or through a private sector landlord. This is an urgent situation and the Council currently has no specific approved policy or decision in place for engagement with the ALES scheme. The Council do have an existing commitment to refugees under the United Kingdom Refugee Scheme (UKRS). This decision was made by Cabinet on 29 October 2020. It was agreed that:

- (a) The proposal made by a community sponsorship group with regard to the resettlement of an additional refugee household in the district under the existing Syrian Refugee Resettlement Scheme be approved.
- (b) The Council should take part in the new United Kingdom Refugee Scheme (UKRS).
- (c) A maximum of 5 additional families are supported through either the existing or the new scheme. Should the existing Syrian scheme reopen and be available locally then under existing commitments 2 of these additional 5 families should be supported through that scheme, leaving a balance of 3 families to be supported under the new UK scheme.

This decision seeks to utilise this commitment whilst expanding the scope to include the ALES with additional provision of 3 families under this scheme. The UKRS and Syrian resettlement schemes specifically are currently on hold nationally and are therefore not presently operating.

## FINANCIAL, LEGAL & EQUALITY ISSUES, IF ANY:

The ALES scheme is sponsored by the Ministry of Housing, Communities & Local Government (MHCLG) under the following terms:

• If a local authority comes forward with an offer of support, for example for a 3-bed house for a couple with 4 children, their ARAP funding package will include funding for the rental at £15 per person, per night for up to 4 months, or until benefits are in place.

- Therefore, to house this family of 6 people, the LA have a nominal 'budget' of £630 per week / £2,730 per month to secure rental accommodation.
- The Department for Work & Pensions (DWP) will support efforts to assist the family into employment, but if the family have not found employment and are affected by their benefit cap of £1666.67 (as a family living outside of greater London) per month, the new fund will enable LAs with ALES to be awarded a 'top up' grant to cover the rent shortfall

Mid Devon Council will formally work the regional Strategic Migration Partnership (SW Councils) and Devon County Council to administer the scheme if any local offers of accommodation support can be made.

A full comparison of the ALES and UKRS schemes is attached for reference.

#### **RISK ASSESSMENT**

Failure to have approval in place for the ALES scheme means the Council cannot engage and provide offers of accommodation support. In turn, this means the Council cannot actively work with the private sectors landlords which have already come forward with potential offers of accommodation and/or consider potential utilisation of the Council's own housing stock (within the Housing Revenue Account). Ultimately therefore, this would be failure to support what is an urgent, vitally important national mission which has local community backing. It is morally imperative that we help these people settle into new lives here in the UK.

The Council have previously approved to engage in other refugee support schemes such as the Syrian Vulnerable Persons Resettlement Scheme under UKRS and the financial security offered under the ARAP provisions for the ALES scheme is as set out above.
