ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

Alcohol shall not be sold or supplied except during permitted hours.

In this condition, permitted hours means:

- a) Monday to Thursday & Sunday, 10.00am until 11.00pm.
- b) Friday & Saturday, 10.00am until 12.00 midnight.
- g) On New Year's Eve from the end of permitted hours to the start of permitted hours on the following day.

The above restrictions do not prohibit:

- a) during the first twenty minutes after the above hours, the consumption of the alcohol on the premises;
- b) during the first twenty minutes after the above hours, the taking of alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;
- c) during the first thirty minutes after the above hours, the consumption of the alcohol on the premises by persons taking meals there if the alcohol was supplied as ancillary to the meals;
- d) the supply to, or consumption by, any person of alcohol in any premises where they are residing.

Alcohol shall not be sold or supplied unless it is paid for before or at the time when it is sold or supplied, except alcohol sold or supplied with and for consumption at a meal supplied at the same time, consumed with the meal and paid for together with the meal.

The club is governed by a Management Committee.

The Committee is responsible for regulating the four licensing objectives as deemed appropriate to the size of the club and the activities carried on within it.

The conduct and discipline of members is covered by paragraph 16 of the Club's constitution.

All activities associated with the club will be supervised by appointed senior club members or officers of the Management Committee who will be responsible for ensuring orderly conduct and good behaviour.

There will be adequate and appropriate supply of first aid equipment and materials will be available for the use of patrons at all times.

The electrical system, including portable appliances will be inspected and tested annually by a competent person to ensure safety.

All safety certificates and inspection reports will be kept on site and made available for inspection by officers of relevant statutory bodies.

The maximum occupancy figures for the premises will be in agreement with the Council and Devon Fire & Rescue based on fire safety issues, available floor space and the sanitary accommodation available.

All external doors and windows will be kept shut, other than for access and egress in all rooms when events involving amplified music or speech or other entertainment likely to give rise to noise.

A senior member of staff (manager) will assess the impact of any noisy activities on neighbouring residential premises at the start of the activity/entertainment and periodically throughout the activity/entertainment.
