<b>Scope of Assessment</b>	The Cullompton Town Centre Masterplan SPD and Delivery Plan will provide a clear strategy to ensure that Cullompton town centre meets its full potential as an attractive, thriving, vibrant place with a strong economic function, now and into the future.
<b>Brief Outline of the Policy or Service</b>	The MDDC Corporate Plan 2020-2024 sets out the District Council’s ambition to support and drive forward sustainable and prosperous communities and economy over a period of time. The Cullompton Town Centre Masterplan SPD and Delivery Plan will provide a strategy for Cullompton town centre to support this ambition.
<b>Main users / beneficiaries</b>	The Cullompton Town Centre Masterplan SPD and Delivery Plan has been produced in accordance with the Council’s Statement of Community Involvement and has been subject to two stages of public consultation. The users and beneficiaries of the document will be: <ul style="list-style-type: none"> <li>• Residents of Cullompton;</li> <li>• Businesses of Cullompton;</li> <li>• Those who visit Cullompton for business or leisure from outside the town or District;</li> <li>• Town Council; District and County Council &amp; associated delivery bodies.</li> </ul>
<b>Information about users, research or other evidence</b>	<p>The District Council has committed to the production of a Town Centre Masterplan SPD and Delivery Plan; agreeing a budget for the engagement of consultants in 2019 to undertake research and develop a draft masterplan for the town centre. The document will enhance the economic prospects of the town including its look and user experience.</p> <p>A consultant contract for Town Centre Masterplan SPD and Delivery Plan was awarded in July 2019.</p> <p>Consultants were engaged and work commenced on the Draft Masterplan SPD and Delivery Plan in 2019.</p> <p>The draft Masterplan SPD has been produced in the context of strategic projects planned in and around Cullompton including the NW Urban Extension, the</p>

	<p>proposed Culm Garden Village, the Cullompton Relief Road, Cullompton Railway Station, Heritage Action Zone project and updated Conservation Area Assessment and Management Plan. Also within the Policy Context of the (now) Adopted Mid Devon Local Plan 2013-2033; the (now) Adopted Cullompton Neighbourhood Plan, the Mid Devon Climate Emergency Declaration, national and local census and market statistics.</p> <p>Multiple meetings have been held with Cullompton Town Council, stakeholders, the District and County Council to discuss the town; its constraints and opportunities as a means to scope the content of the Draft Masterplan SPD. A stage I public consultation was undertaken during 2020 and a Stage II public consultation during 2021.</p> <p>The Draft Masterplan SPD was presented to PPAG during November 2021.</p>
<b>Stakeholder involvement and consultation</b>	<p>Multiple meetings have been held with Cullompton Town Council, stakeholders (including local residents and businesses), the District and County Council. Feedback from consultation events have been taken into consideration when making any changes to the masterplan document.</p>
<b>Equality Issues identified</b>	<p>The masterplan should not see any one group or individual treated less favourably. As a public sector organisation we uphold the best interests of the community including all policies and legislations regarding equality and diversity. All Officers and consultants involved in its production are required to work to company codes of conduct. They will be methodical and inclusive in their approach to all actions from initiation to adoption of the Masterplan SPD and Delivery Plan. The outcomes of the Masterplan SPD and Delivery Plan will not adversely affect any vulnerable users and will not create a negative impact on any protected group.</p>

<b>Overall Recommendation</b>	<p>This assessment has indicated that the Cullompton Town Centre Masterplan SPD and Delivery Plan will have a minimal impact on protected user groups.
