<b>To prevent crime and disorder</b>	Yes	I am concerned that attracting people to the garage during the night will increase crime and disorder. The link between drunkenness and crime and disorder is very well known and being the only local outlet for alcohol after midnight will inevitably cause disorder and crime in this area.
<b>Public safety</b>	Yes	As allowing the sale of alcohol after midnight means that the ASDA shop will be the only local source for alcohol at that time, this would attract drunken people to this area, with an inevitable threat to public safety.
<b>To prevent public nuisance</b>	Yes	Again, allowing this licence will attract drunk people to this area, which means that there is very likely to be a public nuisance in the form of drunken shouting in the middle of the night, as well as other forms of nuisance such as criminal damage to local houses and gardens, littering and anti-social behaviour.
