Section 1 – Summary and Recommendation(s)

This report provides a quarterly update on key environment enforcement performance data including fly tipping, littering, Public Space Protection Orders (PSPOs) and the issuing of Fixed Penalty Notices (FPNs). It also gives a brief summary of Car Parking performance and the issuing of Penalty Charge Notices (PCNs).

Section 2 – Report

- 1.0 This report provides an overview of the Environment and Enforcement service performance during quarter 1 of the 2024/25 financial year.
- 1.1 The Environment and Enforcement service has been focused on assisting Bin It 123 compliance. With side waste no longer being collected, the service has been engaging with residents in problematic areas to determine root cause issues. This has resulted in the service providing advice and assistance to residents relating to storage of waste receptacles, placement of waste, fly tipping and littering.
- 1.2 Engagement with residents has been mostly successful and the service is seeing significant improvements in areas where previously issues seemed to continuously reoccur. The hot spot area projects are very labour intensive, however, the positive benefit justifies the resource allocation.

2.0 Car Parking

2.1 Car parking during Quarter 1 2024/25 has been consistent and the service has maintained daily patrolling of the council assets. User base has been steady with the service seeing positive income compared to Q1 2023/24.

3.0 Environmental Enforcement

- 3.1 The service focus on assisting Bin It 123 has resulted in some positive community changes towards waste. These tactics have resulted in areas having significantly less waste and litter in situ. The service interaction has been one of education and support rather than enforcement at this stage.
- 3.2 The service has used "nudge" tactics such as signage and letter drops to highlight key issues and reaffirm the authority will not tolerate littering or fly tipping in communities. These tactics have resulted in positive behavioural change, leaving the service to focus attention on those members of communities who continue to disregard environmental law.

3.4 Whilst there has been an evident reduction in littering and FPNs issued, there have been small increases in PSPO instances, Fly Tipping and Abandoned Vehicles.

3.6 Fly Tipping has seen a slight increase in received reports during the last quarter. It is felt that this is likely due to increased confidence in the service from members of the public that action will be taken following reports rather than an increase in fly tipping instances generally across the District.
