Dear Licensing Officer,

I am writing to formally object to the application for a new premises licence at 23 Bampton Street, Tiverton, Ex16 6AA.

My objection is ^{based} on the following grounds under the Licensing Act 2003 objectives.

1. Prevention of Public Nuisances

There are already multiple licenced premises in close proximity. Another licence would exacerbate noise levels, particularly during Late hours, disturbing Local residents' peace and quiet

2. Prevention of Crime and Disorder:

An increase in alcohol availability contributes to higher rates of public intoxication and related antisocial behaviour, which is already a concern in this area. In recent years there have been number of break ins related to alcohol, which ~~is~~ adds more strain to already struggling public sectors ie police.

Given those concerns, I urge the Licensing
Committee to reject the application.
